FACILITIES/RECYCLING (Jon Knittel)

- Odor Update: Gas collection from Cell 7 was doubled by volume on Tuesday October 17, 2023. Additional horizontal gas collectors will also be installed to increase the negative pressure within the new cell. Pipe arrived this week and contractor is scheduled to weld and install pipe. The horizontal collector should be online by Friday, October 27th. The entire landfill was scanned by outside consultant twice in past two weeks looking for any unknown hotspots. Additional daily and intermediate cover is being used until the new horizontal gas collectors go online. Fenceline H2S readings have been measured up to 2 parts per billion (ppb) during the early pre sunrise hours on occasion and when temperature gradient thermals are traveling downhill. Detection is more readily noticed when fog is lying low in the Pequest Valley.
- West Slope Cap Project: Functioning as intended reducing odor and leachate.
- Permanent Closure Cap Update: 95% drawings available at the office. Specifications underway. November 20th estimated date for request to board for a motion to bid.
- Closure Fund Disbursement Request: Two requests are pending with NJDEP. Third request to go out soon.
- Residential Clean Processed Dredge Material successfully imported over a 12-day period. This material is integral for shaping and cushion layer for the permanent cap installation in 2024.
- Cell 7 Construction Completion: Last 20% of the retainage likely to be released this month after submission report is sent to NJDEP.
- FEMA (IDA) Drainage Repair Project: October 31st completion deadline on track.
- A-2 Change Order CO-4 and CO-6 for board approval (motion) for site repairs
 - Update on leachate hauling automated kiosk on scale #2: Leachate lagoons have been emptied since recent unseasonably wet period. Kiosk is delayed but should arrive within one month. Kiosk will allow tankers to weigh out during off hours.
