- Onsite Waste Water Treatment Plant Evaluation/Upgrade: The evaluation is underway of existing treatment plant equipment condition after being in a mothball state for the past 6 years. The second and final round of leachate quality analysis is underway to establish initial treatment design parameters.
- 20 Acre Side Slope Cap Project Update: Barbella has stopped work in December due to frozen ground. Work will resume when weather improves.
- Odor Update: Regular surface monitoring continues. Additional gas collectors will be added periodically. A gas header installation project was delayed temporary pending budget rollover to the new year and any word from NJDEP regarding funding source approval. Thermal imaging via drone is schedule for next week to look for any hotspots in Cell 7. Two new gas wells installed during the capping project are now online this month at the ridgeline of Cell 1 to 5 (Well #73 and #75)
