FACILITIES/RECYCLING (Jon Knittel)

- Cell 6A pre construction has commenced. Select tree removal and stump removal has begun. Erosion control will be added in the coming days prior to topsoil removal and stockpiling. Excavation to base grades will be underway for the next 12 months using in house machinery (2 off road trucks and the CAT 336 Excavator). In house labor is not currently able to staff this operation.
- Preliminary design was completed by the Director and submitted to Mott MacDonald for final review and cost analysis for a new access road into Cell 7 from the high side of the site. The current access road comes in from the low side and has a shortening lifespan due to increasing grades and Cell orientation.
- Wastewater Treatment Plant Pilot RO study is waiting for analytical data to come back on treatment efficiency., PFAS, rejection rate, rejection analytical and cost analysis. Data (lab turnaround time) and the following analysis may take about 6 to 8 weeks.
- Cap Project is complete with last Payment application expected for the November meeting.
 - A-3 Change Order #10 for net amount of \$2,638.00 For Board Approval.
- Gas Collection Expansion: The 6 new gas wells, a new 16-inch and 12-inch gas header collector pipe have been in service for several weeks. The Draft payment application was received just prior to this meeting for approximately \$425,000 (underbudget and on time). PCFA and engineer met with WAGA Energy to discuss feasibility of cleaning and compressing our landfill gas for sale and introduction to the

nearby gas distribution pipeline at East Quarry Rd. Current flow is approximately 1,000 SCFM at 40% methane.

- Director met with AMP Recycling regarding industry trends in onsite (landfill) sorting and processing of ID-10 solid waste with approximately 50% recycling rates with no loss in revenue by space saving through material diversion (recyclables) and ability to fit more waste in the same space by shredding/sorting.
