- Landfill Compactor Replacement: The TANA compactor has been onsite and is demonstrating exceptional performance for a several week trial period. The staff and capital committee are pleased with the performance and PCFA is finalizing paperwork to purchase through a Co-op purchasing option. Resolutions today establish the final part of the process in completing the purchase.

- New access road progress slowed pending GPS installation on site in the coming two weeks. The in-house GPS will allow us to perform the soil cuts needed for this road alignment without frequent and expensive outside surveying help. Brush clearing and dead trees are being cleared out of the upper reaches of Cell 6A near where the County 911 Radio Tower will be installed. A turnaround/laydown area for both Cell 6A construction and the Radio Tower construction is being cut in for heavy equipment/truck turnaround access.
- County Radio Tower: A County Pre bid meeting was successfully held onsite last week. Award and then construction is anticipated for the spring. Construction will not interfere with landfill facility operations due to the remote location.
- Wastewater Treatment Plant Pilot RO study is complete with a full report upcoming. A presentation of the findings is expected at a coming meeting either by the Director or by the Tetra Tech.

- Gas Collection Expansion: The 6 new gas wells, a new 16-inch and 12-inch gas header collector pipe are performing well. The enclosed flare is running smoothly and continuously now that some new gas is being recovered.
