



Pisgah Avenue, Post Office Box 587, Oxford, New Jersey 07863-0587, and clearly marked on the outside "**BID FURNISHING CONTRACTOR SERVICES FOR HOUSEHOLD HAZARDOUS WASTE COLLECTION DAYS 2024/2025.**" Each bid must be accompanied by a certified check, cashier's check or bond in the amount of ten percent (10%) of the total bid, but not to exceed \$20,000.00, payable to the **Pollution Control Financing Authority of Warren County.**

All Bidders must comply with the mandatory requirements of N.J.S.A. 10:5-3.1 et seq. (P.L. 1975, c. 127) and N.J.A.C. 17:27 regarding Affirmative Action responsibilities of contractors.
